Ordinance No. 956 7/1/95 Resolution No. 22-36, 06/14/2022

On October 11, 2017 Governor Brown signed into law SB-1379 which increases a state fee of \$1 to \$4 on any applicant for a local business license or similar instrument or permit, or renewal thereof. The purpose is to increase disability access and compliance with construction-related accessibility requirements and to develop educational resources for businesses in order to facilitate compliance with federal and state disability laws, as specified. Additional \$4.00 will be added at time of receipt.

Workers' Compensation (Section 3711 of the Labor Code):

Failure to secure Workers' Compensation coverage is unlawful and shall subject an employer to criminal penalties and civil fines up to \$100,000 in addition to the cost of compensation, damages as provided for in Section 3706 of the Labor Code, interest and attorney fees.
