

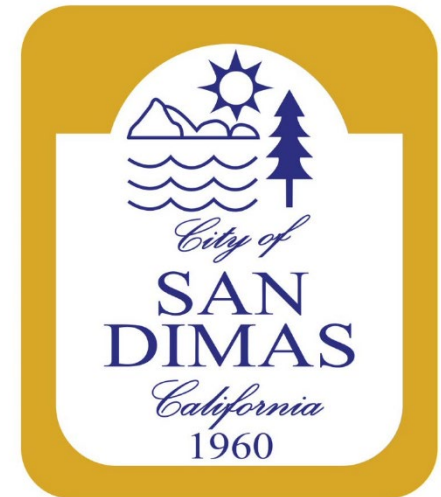

WHAT ARE TEMPORARY NON-RESIDENTIAL FOR SALE / FOR LEASE SIGNS AND BANNERS?

Temporary nonresidential real estate signs and banners pertain to the sale and/or lease of a nonresidential building or property.

APPLICATION

An application for a temporary non-residential real estate sign or banner shall be made on forms provided by the Planning Department. The application includes a description of the building and/or tenant spaces available for sale or lease. The banner information (length and height) are required on the application. The property owner is required to sign the application prior to submittal.

The applicant shall submit a site plan indicating the exact location of all the signs and/or banner(s) proposed for the site and/or units. Color photos showing the location of the vacant unit(s) and the location of the proposed banner(s) are also required with the application submittal.

BUILDING MOUNTED SIGNS

Building mounted signs may be permitted based on the following information:

- One banner or other similar sign, mounted on the building or window or other location of the tenant space and/or building available for sale or lease, not to exceed sixteen square feet.
- For integrated retail, office or industrial centers or parcels greater than one hundred feet in width, additional banners or similar signs may be

permitted by the planning department, not to exceed 40 square feet each. Such signs shall generally be on the available tenant or building space but may be approved in other locations as deemed necessary by the planning department. Banners may not exceed the height of the building parapet.

TIME LIMIT

Temporary permits shall be valid for a maximum of six months provided that all such signs shall be removed within fourteen days of the sale or leasing of available space. A new permit may be issued if spaces and/or buildings remain available for sale or lease.

UNDEVELOPED PROPERTY

For undeveloped property, one sign not exceeding sixteen square feet in sign area and six feet in height may be allowed based on the approval by the Planning Staff.

PROHIBITED

There are various types of “for lease” signs and techniques available to attract potential clientele; however, the following are not permitted within the City of San Dimas: streamers, pennants, balloons, hand-held signs, lighting and similar devices.
