Dear Mr. Constantin:

Thank you for your letter regarding your opposition to converting Camps Paige/Afflerbaugh or Camp Glenn Rocky into a permanent Secure Youth Treatment Facility.

The public input process is extremely important to me. I agree that our residents are important stakeholders in this process as are our law enforcement partners. When I learned that the Juvenile Justice Realignment Block Grant (JJRBG) Subcommittee was planning to make a recommendation without proper community engagement, I introduced a motion calling for an analysis of all camps and halls in the county and for there to be an opportunity for community participation and dialogue.

Therefore, I strongly urge our residents to share their concerns with the JJRBG subcommittee and with the rest of the Board of Supervisors. I also highly encourage residents to attend the next Town Hall which will be hosted virtually by the Probation Oversight Commission (POC) on January 5th. For more information visit the POC website by going to: poc.lacounty.gov/Meetings/Town-Halls.

While there is not an exact date on when the recommendation for the permanent Secure Youth Treatment Facility will be made by the JJRBG to the Board of Supervisors, I do expect a recommendation to come sometime in late January or early February. I cannot stress enough how important it is for our shared constituency to remain engaged in the selection process.
