

RESOLUTION 2023-68

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN DIMAS, COUNTY OF LOS ANGELES, PROHIBITING PARKING OR STOPPING OF VEHICLES FOR STREET SWEEPING ON CERTAIN STREETS

WHEREAS, Section 22507 of the California Vehicle Code and Sections 10.24.095 and 10.24.104 of the San Dimas Municipal Code permit the City Council, by resolution, to designate streets on which parking or stopping is prohibited; and

WHEREAS, Section 463 of the California Vehicle Code defines "Park or Parking" to mean the standing of a vehicle occupied or not, otherwise than temporarily for the purpose of and while actually engaged in loading or unloading merchandise or passengers

WHEREAS, the City Council further resolves that the term merchandise in section 463 of the California Vehicle Code also include items defined as goods for the purposes of the City parking restrictions.

NOW, THEREFORE, BE IT RESOLVED, it is determined necessary that parking or stopping be prohibited on certain city streets the City Council does find, determine, and declare as follows:

SECTION 1. Parking or stopping shall be prohibited as follows:

A. The following streets shall be marked or posted with the following TIME LIMITS or PARKING RESTRICTIONS:

4	Acacia St.	Acacia St. (both sides) Bonita Ave. -Arrow Hwy. "No Parking on 1st Tuesday of every month 8 A.M.-11 A.M." (West side of street) and "No Parking on 2nd Tuesday of every month 8 A.M.-11 A.M" (East side of street)

5	Baseline Rd.	Baseline Rd. (South side) San Dimas Ave.-Shoshone Ct. "No Parking on 2nd Tuesday of every month 8 A.M.-11 A.M" (South side of street)
6	Covina Blvd.	Covina Blvd. (North side) Derby Rd.-Lone Hill Ave. "No Parking on 1st Tuesday of every month 8 A.M.-11 A.M." (North side of street)
7	Lone Hill Ave.	Lone Hill Ave. (East side) W Covina Blvd. -Brighton Court. "No Parking on 2nd Tuesday of every month 8 A.M.-11 A.M." (East side of street)
8	Walnut Ave.	Walnut Ave. (West side) Bonita Ave. -Train tracks "No Parking on 1st Tuesday of every month 8 A.M.-11 A.M." (West side of street)
9	W Cypress Ave.	W Cypress Ave (North side) N Valley Center Avenue – approximately 130ft east of Canterbury Lane "No Parking on 1st Tuesday of every month 8 A.M.-11 A.M." (North side of street)
10	S Maimone Ave	S Maimone Ave (both sides) W Arrow Hwy – W Calora Street "No Parking on 1st Tuesday of every month 8 A.M.-11 A.M." (West side of street) and "No Parking on 2 nd Tuesday of every month 8 A.M.-11 A.M" (East side of street)
11	N Amelia Ave	N Amelia Ave (both sides) W 5th Street – approximately 315ft south of Highland Place "No Parking on 1st Tuesday of every month 8 A.M.-11 A.M." (West side of street) and "No Parking on 2nd Tuesday of every month 8 A.M.-11 A.M" (East side of street)
12	Tanglewood Lane	Tanglewood Lane (both sides) Puddingstone Drive – end of Tanglewood Drive "No Parking on 1st Tuesday of every month 8 A.M.-11 A.M." (North side of street) and "No Parking on 2nd Tuesday of every month 8 A.M.-11 A.M" (South side of street)
13	Iron Bark Lane	Iron Bark Lane (both sides) Tanglewood Drive – end of Iron Bark Lane "No Parking on 1st Tuesday of every month 8 A.M.-11 A.M." (North side of street) and "No Parking on 2nd Tuesday of every month 8 A.M.-11 A.M" (South side of street)
