- As businesses start to re-open, prioritizing the safety of their employees and customers from COVID-19
 is essential. The State of California has released new industry guidance to help businesses reduce the

- Driver's license permits expiring March-June 30, 2020 are EXTENDED 6 months OR to a date 24 months from the date of application, whichever is earlier. - Governor Newsom last week issued an executive order that extends some critical deadlines that have been impacted by the COVID-19 pandemic
 - The executive order extends deadlines for certification requirements for public school project inspectors who previously passed an initial evaluation, as well as Certified Access Specialists who ensure compliance with disability access in properties and businesses. The order also gives the State Fire Marshal 60 days to publish lists of building materials requirements and registration renewals for flame-retardant fabrics and applications

- Los Angeles County beaches will reopen on Wednesday, May 13 for ocean activities and exercise (running, walking, swimming, and surfing) with these restrictions:
 - Gathering, sitting, and sunbathing are **NOT** allowed
 - At least 6 feet physical distancing required
 - Face coverings are mandatory when out of the water and around others
