- The Los Angeles Department of Public Health issued an updated Health Order yesterday, March 13. The Health Officer has ordered the continued closure of 'high-risk businesses, recreational sites, commercial properties, and activities, where more frequent and prolonged person-to-person contacts are likely to occur,' which includes indoor and outdoor flea markets and swap meets.
 - As a result, all garage sales and/or yard sales are temporarily suspended within the City of San Dimas until further notice
 - Garage/yard sales may not be held at any driveway, dwelling, garage, premises, property, or public space
