## Latest Updates:

- There's still time to file your taxes and claim a refund with the California Earned Income Tax Credit.

  Due to disruptions caused by the COVID-19 Pandemic, the state and federal tax filing deadline for this year is now July 15
  - o California residents who made less than \$30,000 in 2019 may be eligible for up to \$8,000 in state and federal tax credits, depending on income and family size
  - Have kids under six years old? Get an extra \$1,000 with the Young Child Tax Credit

- Household Hazardous and Electronic Waste collection events will be back beginning July 18 in La Puente
  - o The event will be held at La Puente Park, 501 N Glendora Avenue from 9 am to 3 pm
  - The event is open to everyone and you are encouraged to bring medicines, used needles, paints, household cleaners, old computers, and TVs

- The Sanitation Districts have created a rebate program to aid businesses facing financial challenges due to the COVID-19 stay-at-home orders. This program provides a simplified way for commercial users/properties with reduced wastewater discharges to potentially receive a reduction in their wastewater service charge for the period of March 20 to June 30, 2020. If your business was impacted by COVID-19, you may qualify for a rebate in some of your wastewater service fees
