 - Do not run extension cords under rugs or near furniture
 - Throw away damaged cords
 - Pick up tripping hazards like toys and shoes

- LA County is beginning to see key COVID-19 metrics move in the right direction, including lower positivity and hospitalization rates in the County. To help LA County childcare providers, teachers, administrators, and parents prepare for a return to in-person learning, DPH has issued guidance which shows what symptom & exposure screenings in children will look like, once children return to early care, education centers, and K-12 schools. DPH guidance includes:
 - A symptom and exposure screening process for children before returning to educational institutions
 - Steps for handling exposure to a child with symptoms consistent with COVID-19 at an educational institution
 - Steps for handling exposure to a child or staff member with a laboratory-confirmed COVID-19 infection at educational facilities
