Latest Updates:

Local:

- Bobcat Fire update: the fire is currently 114,438 acres and 63% contained. Fire activity is limited to mainly smoldering within containment lines, and it should stay nearly within the existing footprint. Firefighters continue to patrol and mop up. - We currently have two vacancies on the Parks and Recreation Commission. Qualifications: Members must be residents of the City of San Dimas. Length of Term: Three (2) two-year terms Terms expire in 2026.

County:

- The school waiver program will begin accepting applications for TK-2 in-person instruction in early October.
 The issuance of waivers will be prioritized to schools with higher percentages of students qualified for
 free/reduced meals. Schools must also be able to open in full adherence with the LA County school
 reopening protocols. The application process will be available online at <u>publichealth.lacounty.gov</u> and will be
 launched in early October
- The Los Angeles County Procurement Technical Assistance Center (PTAC) offers one-on-one technical assistance and training to help businesses in Los Angeles County interested in local, state, and federal government contracting. PTAC Counselors can help your business with most government contracting matters, including becoming a registered vendor, getting certified, finding opportunities, target market analysis, and marketing to the government. - UPDATE ON REOPENINGS: The following sectors can reopen with restrictions over the next ten days. LA
 County Public Health will finalize the dates for each sector's reopening by Friday, October 2
 - Cardrooms may reopen for outdoor gaming only. Food and beverages may not be served in cardrooms at this time
 - Indoor shopping malls will be allowed to reopen at 25% occupancy, with food courts and all common areas remaining closed
 - Nail salons may reopen for some indoor services, limited at 25% occupancy. We encourage you to continue to offer services outdoors, as the air circulation is better and there is a lower risk of disease transmission outdoors
 - Outdoor playgrounds may reopen, at the discretion of cities & the County Parks and Recreation Department. All parents and children age 2 & older must wear a cloth face covering, no eating or drinking, and parents are encouraged to monitor their children to ensure physical distancing.
 - The County is working on exploring the process for reopening Breweries and Wineries that serve meals
