

RESOLUTION 2022-42

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN DIMAS, CALIFORNIA,
RECITING THE FACT OF THE GENERAL MUNICIPAL ELECTION HELD ON JUNE 7, 2022
DECLARING THE RESULT AND SUCH OTHER MATTERS AS PROVIDED BY LAW**

WHEREAS, a Municipal Election was held and conducted by the Los Angeles County Registrar-Recorder/County Clerk in Norwalk, California, on Tuesday, June 7, 2022 as required by law; and

WHEREAS, notice of the election was given in time, form and manner as provided by law; that candidates were nominated to fill the vacancies as provided by law; that voting precincts were properly established; that election officers were appointed and that in all respects the election was held and conducted and the votes were cast, received and canvassed and the returns made and declared in time, form and manner as required by the provisions of the Elections Code of the State of California for the holding of elections in general law cities; and

WHEREAS, the Los Angeles County Registrar-Recorder/County Clerk canvassed the returns of the election and has certified the results to this City Council, the results are received, attached and made a part hereof as "Exhibit A."

**NOW THEREFORE, THE CITY COUNCIL OF THE CITY OF SAN DIMAS,
CALIFORNIA, DOES RESOLVE, DECLARE, DETERMINE, AND ORDER AS FOLLOWS:**

SECTION 1. That the whole number of ballots cast in the precincts except absent voter ballots was 1,863.

That the whole number of absent voter ballots cast in the City was 6,323 making a total of 8,186 ballots cast in the City.

SECTION 2. That the names of persons voted for at the election for Mayor are as follows:

Emmett G. Badar

SECTION 3. That the names of persons voted for at the election for Member of the City Council are as follows:

District 2
Eric Nakano
Brandon Moon

District 4
Ryan A. Vienna

SECTION 4. That the number of votes given at each precinct and the number of votes given in the City to each of the persons above named for the respective offices for which the persons were candidates were as listed in Exhibit "A" attached.

SECTION 5. The City Council does declare and determine that: Emmett G. Badar was elected as Mayor for the full term of two (2) years; Eric Nakano was elected as Member of the City Council in District 2 for the full term of four (4) years; and Ryan A. Vienna was elected as Member of the City Council in District 4 for the full term of four (4) years.

SECTION 6. The City Clerk shall enter on the records of the City Council of the City a statement of the results of the election, showing: (1) The whole number of ballots cast in the City; (2) The names of the persons voted for; (3) For what office each person was voted for; (4) The number of votes given at each precinct to each person; (5) The total number of votes given to each person.

SECTION 7. That the City Clerk shall immediately make and deliver to each of the persons so elected a Certificate of Election signed by the City Clerk and authenticated; that the City Clerk shall also administer to each person elected the Oath of Office prescribed in the Constitution of the State of California and shall have them subscribe to it and file it in the office of the City Clerk. Each and all of the persons so elected shall then be inducted into the respective office to which they have been elected.

SECTION 8. That City Clerk shall certify to the passage and adoption of this Resolution and enter it in to the book of original Resolutions.
