PUBLIC NOTICE OF ADOPTION OF ORDINANCE- SUMMARY

NOTICE IS HEREBY GIVEN that on June 25, 2024 the City Council of the City of San Dimas, California, introduced, and on July 23, 2024 adopted, an Ordinance entitled:

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF SAN DIMAS, CALIFORNIA, AMENDING SAN DIMAS MUNICIPAL CODE CHAPTER 14.11 AND CHAPTER 14.13 OF TITLE 14 (WATER AND SEWERS) UPDATING THE STORMWATER MANAGEMENT AND DISCHARGE AND LOW IMPACT DEVELOPMENT (LID) REQUIREMENTS FOR NEW DEVELOPMENT AND REDEVELOPMENT PROJECTS AND INCORPORATING THE REGIONAL PHASE I MUNICIPAL SEPARATE STORM SEWER SYSTEM (MS4) PERMIT REQUIREMENTS ASSOCIATED WITH DISCHARGE AND CONNECTION TO THE STORM DRAIN SYSTEM, AND CONTROL OF STORMWATER AND NON-STORMWATER RUNOFF

The Ordinance (Ordinance No. 1306) amends the San Dimas Municipal Code to ensure City compliance and San Dimas Municipal Code consistency with the latest MS4 Permit adopted by the Los Angeles Regional Water Quality Control Board (Order No. R4-2021-0105). This permit establishes requirements for stormwater and non-stormwater discharges and requires the City to address and measure the quality and quantity of stormwater runoff. Changes made by Ordinance 1306 include the following:

- Adds and revises various definitions in Chapters 14.11 and 14.13. Removes and replaces various terms in Chapter 14.13.
- Revises section titles in Chapter 14.11 for consistency with the updated MS4 Permit.
- Adds a new section 14.11.050 to identify prohibited connections and identifies removal authorities granted to the City Engineer.
- Adds a new section 14.11.070 pertaining to industrial and commercial facilities, identifies prohibited discharges and activities, permitting requirements, and best management practices for industrial and commercial facilities.
- Revises section 14.11.090 to incorporate updated best management practices for all construction projects.
- Revises section 14.11.120 to identify the actions that may be carried out in the course of an inspection to include monitoring and sampling (as necessary), records review, and photographic evidence to be collected. Also establishes prohibitions for interference with an inspection.
- Makes formatting and clarifying changes to section 14.11.130 regarding enforcement and penalties.
- Revises Article III of Chapter 14.13 pertaining to New Development and Redevelopment Projects to be consistent with the updated MS4 Permit.
- Revises section 14.13.070 to add on-site flow-based best management practices and ground water replenishment projects as Alternative Compliance Measures.
- Adds a new section 14.13.080 pertaining to hydromodification management requirements to include new requirements consistent with the updated MS4 permit for projects located within natural drainage systems.
- Revises section 14.13.110 to include a signed Maintenance Agreement as a condition for issuing a certificate of occupancy for New Development and Redevelopment projects and adds an annual certification requirement and biennial inspection notice.
