<p><b><u>07-24-01 Intersection of 400 Block of N Walnut Ave and 200 Block of E 5 Street</u></b>  <i>Request by Resident, to review and consider creating a designated crosswalk across N Walnut Ave at E 5 Street.</i></p>	<p><b>Comments/Recommendations:</b></p> <ul style="list-style-type: none"> <li>• <i>Install signage prohibiting pedestrian crossing and direct to crosswalk at Walnut Ave &amp; Juanita Ave with R9-3 &amp; R9-3bP sign assembly double sided on both sides of Walnut Ave at E 5<sup>th</sup> Street (install at NWC, SWC, NEC, &amp; SEC).</i></li> <li>• <i>Install additional signage prohibiting pedestrian crossing and direct to crosswalk at Walnut Ave &amp; Juanita Ave with R9-3 &amp; R9-3bP sign assembly double sided at Walnut Ave &amp; 4<sup>th</sup> St (install at SWC &amp; SEC Note: NWC &amp; NEC are existing)</i></li> <li>• <i>Staff to work with School to generate &amp; distribute a notice to encourage safe routes to school.</i></li> </ul>

<p><b><u>07-24-05 N Amelia Ave Line of Sight Concern</u></b> Request by Resident, to review the line of sight concern regarding vehicles parked in front of 920 N Amelia and the vehicles exiting 978 N Amelia Ave business center.</p>	<p><b>Comment/Recommendations:</b></p> <ul style="list-style-type: none"> <li>Staff to send letter to resident at 920 N Amelia Ave to trim vegetation. A previous letter was sent in 2018 regarding the same concern.</li> </ul>
<p><b><u>7-24-06 San Dimas Canyon Road and Sycamore Canyon Road</u></b> Request from Staff, to review proposed location of equipment installation by Edison</p>	<p><b>Comment/Recommendations:</b></p> <ul style="list-style-type: none"> <li>For safety concerns, TSC would like to avoid proposed location at NW corner of San Dimas Cyn Rd &amp; Sycamore Cyn Rd.</li> <li>TSC recommends the installation be done at the alternative location on County Park property that was proposed by Edison.</li> </ul>

<p><b><u>05-24-02 Speed Concern on Via Vaquero</u></b> Request by Resident, to review and consider to change speed limit from 25 mph limit to 15 mph limit on Via Vaquero.</p>	<p><b>Comments/Recommendations</b></p> <ul style="list-style-type: none"> <li>Staff reviewed Speed Feedback Trailer Data.</li> <li>Based on data reviewed, staff to place speed feedback trailer for an additional week at an alternate location to collect additional data for EB Via Vaquero.</li> <li>This item will be continued.</li> </ul>
<p><b><u>03-24-01 Eaton Road Red Curb Request</u></b> Request by Resident, to review and consider installation of red curb on a portion of Eaton Road in front of 1141.</p>	<p><b>Comments/Recommendations</b></p> <ul style="list-style-type: none"> <li>TSC reviewed the Stopping Sight Distance on Horizontal Curve provided by the City's Traffic Engineer.</li> <li>Red curb is recommended in front of 1141 Eaton Rd per the line of sight diagram provided by the Traffic Engineer.</li> <li>Staff to send a letter to the resident at 1141 Eaton Rd to notify of the red curb installation.</li> </ul>

<p><b><u>03-24-06 Oakway Avenue and Ghent Avenue</u></b>  <i>Request by Resident, to review and consider stop signs to be installed at Oakway Ave and Ghent Ave.</i>                  GoGov Request #2024-0517,                  GoGov Request #2024-0569, and                  GoGov Request #2024-1277</p>	<p><b>Comments/Recommendations</b></p> <ul style="list-style-type: none"> <li>• TSC reviewed stop sign request and reconfirms recommendation made at 9/16/20 TSC meeting per Item No. 03-20-01 (No “Stop” sign for any direction recommended)</li> <li>• Staff reviewed Speed Feedback Trailer Data.</li> <li>• Staff to send letter to resident regarding speed data findings which showed the highest frequency of vehicles exceeding the speed limit occurred primarily in the afternoon from 1pm to 4pm.</li> <li>• Staff to request Sheriff’s Department provide additional enforcement targeting the afternoon hours of 1pm to 4pm.</li> <li>• The City will look into installing additional multi-use trail on the west side of Oakway Ave just north of Ghent St.</li> </ul>
