#03-23-01 SOUTH WALNUT AVE (FIRE STATION #64)

REQUEST FROM STAFF, to review and consider installation of Keep Clear striping in front of Fire Station #64 to deter vehicles from queuing in front of the Fire Station and impacting their response time.

#03-23-02 PLACER DR

REQUEST FROM SHERIFFS DEPT, to review and consider installation of red curb in front of mailboxes to deter vehicles from parking in front of them (near property line of 630 and 642 W Place Dr).

#03-23-03 NORTHSIDE COVINA BL, EAST OF LONE HILL AVE

REQUEST FROM RESIDENT, to review and consider installation of parking restriction on the north side of Covina Bl just east of Lone Hill Ave to assist with traffic flows for the westbound to northbound right turn movements. Resident has observed vehicles parking in the area for drop off/pick up of students during school peak hours. (GG#2023-0203).

#03-23-04 6th ST FOR EASTBOUND TRAFFIC AT MONTE VISTA

REQUEST FROM RESIDENT, to review and consider installation of 25mph signage on 6th Street off of Monte Vista for eastbound traffic to assist with perceived speeding from Monte Vista to San Dimas Ave on 6th St.

#03-23-05 FIRST ST / IGLESIA (FARMERS MARKET 2023)

REQUEST FROM STAFF, to review traffic control plans for City's Farmers Market event scheduled to run from April 5 through September 13, 2023. Event temporarily closes City Hall Parking Lot and First Street on Wednesdays from 3pm-10pm.

#03-23-06 CIVIC CENTER PARK (EASTER EGG HUNT 2023)

REQUEST FROM STAFF, to review traffic control plans for City's Easter Egg event scheduled for April 1, 2023. Event temporarily closes First St from 8am-12:30pm.

#03-23-07 CITY MUNICIPAL PARKING LOT (CARS & COFFEE 2023)

REQUEST FROM STAFF, to review site plan for event which does not close any city streets and is scheduled for the following Saturdays: April 15, May 20, June 17, July 15, August 19, 2023. Event temporarily closes the municipal parking lot behind Walker House from 6:30am-11am.

#03-23-08 SOUTH SAN DIMAS AVE, SOUTH OF BONITA

REQUEST FROM STAFF, to review and consider enhancements for southbound San Dimas Ave south of Bonita Ave (Gold Line crossing) to assist with perceived line of sight concerns at the railroad crossing for cars queuing at Commercial St. Per GoGov request, vehicles are traveling about 40mph and do not notice cars queuing until over the train tracks almost causing collisions during [school] peak hours. #11-21-03 LONE HILL AVE / CYPRESS ST INTERSECTION

REQUEST FROM RESIDENT, to review and consider performing a traffic study of this intersection as vehicle traffic is impeding students from safely using the crosswalks during the peak school hours (Mon-Fri, 8:30am-9am and 3:30-4pm). Resident is requesting additional resources be dispatched daily or crossing guard / police presence.

#11-21-04 LONE HILL AVE / CYPRESS ST INTERSECTION

REQUEST FROM LONE HILL PRINCIPAL GRIBBON, to review and consider installation of crossing guard or blinking lights in cross walk to assist students crossing the intersection during high traffic times (peak school hours). Principal Gribbon has received several complaints from Lone Hill Middle School parents.

#01-23-07 BONITA AVE (HEART OF THE FOOTHILLS)

REQUEST FROM STAFF, to review traffic control plans and site plan for the Heart of the Foothill's event scheduled for Sunday, April 23, 2023. This event will temporarily close Bonita Ave (Cataract Ave to eastern City Limit) from 5:00am to 5:00pm.
