**MANDATORY COMMERCIAL ORGANICS RECYCLING  
WAIVER REQUEST**

Senate Bill 1383 (SB 1383) and Assembly Bill 1826 (AB 1826) both mandate the recycling of organic waste. In effect, all businesses and multi-family complexes must retain an organics recycling program. Organic waste includes: food waste, green waste, landscape and pruning waste, non-hazardous wood waste, and food-soiled paper waste that is mixed in with food waste.

Additionally, AB 341, requires businesses that produce more than 4 cubic yards of solid waste to recycle effective July, 1 2012.
