#11-23-01 4th Street and Eucla Avenue

REQUEST FROM RESIDENT, to add stop signs on 4th Street. Add more "slow down" signs, speed bumps or dips, add flashing crosswalk.

#11-23-02 Holiday Half Marathon

REQUEST FROM STAFF, to review traffic control plans for the Holiday Half Marathon event that is scheduled for Saturday December 9 (Fairplex Property) & Sunday December 10 (Race Day) This event will temporarily close eastbound Puddingstone from Cannon Avenue to Fairplex Drive and local access will be maintained by detouring on to Cannon Avenue to Walnut Avenue for Puddingstone Drive residents.

#11-23-03 Lantern 5K Walk- Life Pacific University

REQUEST FROM STAFF, to review traffic control plans for Lantern 5k Walk event that is scheduled for April 6, 2024. No street closures are required for this event.

#11-23-04 Cataract and Foothill Avenue

REQUEST FROM RESIDENT, to install lower profile or remove vegetation on the median. Reconfigure the u-turn lane and make it a merge lane. Lower the speed limit on Foothill. Install traffic lights or other signals.

09-23-05 Saints Court (Recreation Center Crosswalk)

REQUEST FROM STAFF, to review and consider installation of designated crosswalk for Recreation Center patrons from San Dimas High School parking lot.

Recommendations: 1.) Traffic engineer to conduct a crossing study/analysis and provide results at future meetings 2.) Item continued to next meeting.

09-23-08 1009 W Gladstone (W/O Tracks)

REQUEST FROM RESIDENT, to review traffic concerns on Gladstone relating to driveway access.

Recommendations: 1) Staff will communicate with resident; due to numerous restrictions of driveway and street, an option would be for resident to widen the approach- move fence to west and the city could assist with widening approach on west (near the fire hydrant) 2.) Minutes sent to resident 3.) Letter to be sent.
